Membership Application 2017

The **Colorado Society of Private Investigators (CSPI)** membership application is designed to provide the Board of Directors information concerning your background. **There is no application fee** and you can complete the application online, print, and send the required documentation. If you need additional space, please type all responses on additional pages as required and submit with your application.

Like you, we understand this is a membership application, not to be confused with a national security clearance or application to a clandestine operation. Prying into your personal life is not on our agenda; the CSPI Board of Directors is genuinely interested in you, your company, and your future success.

CSPI has three membership classifications. They are:

1. **Professional Member**

Any private investigator who maintains a current Colorado private investigator license issued by the State of Colorado. A professional member can vote, hold office, and has LIST SERV privileges.

2. **Associate Member**

a. Any person engaged in the business of process serving whose primary residence and business is located in the state of Colorado and is in good standing with the Colorado Secretary of State's Office.

or...

b. Any person who maintains an active private investigation license in another state and is in good standing with that state's licensing authority.

An associate member has LIST SERV privileges and can vote and hold office.

3. **Affiliate Member**

Any person 21 years or older whose primary residence is located in the state of Colorado **and has an interest in** the private investigation profession, however, does not meet the requirements of either the professional or associate member. Affiliate members are entitled to LIST SERVE privileges, however, cannot vote or hold office.

4. **Vendor Member**

Any person or business providing a service or product for the investigation industry. Private investigators may list products for sale and educational opportunities, but not investigation services. A separate vendor application can be obtained from CSPI President Rick Johnson, rick@denverpi.com.

Professional Membership application **must include** the following:

- A copy of your current Colorado Private Investigator's license.

Associate Membership application **must include** the following:

For Colorado Process Servers:

- Please include a copy of your Colorado Bureau of Investigation criminal history (www.cbirecordscheck.com). The cost is \$6.85 which can be charged to your credit card.
- Please include your Certificate of Good Standing from the Colorado Secretary of State's Office.

Out of State Private Investigators must include

- A copy of your current private investigator's license.

Affiliate Membership application **must include** the following:

- Those persons applying for membership under this category, if a Colorado resident, must attach to your application your Colorado Bureau of Investigation criminal history (www.cbirecordscheck.com). The cost is \$6.85 which you can charge to your credit card. If you are a non-Colorado resident, you must provide your state's arrest history.

Membership Fee

The annual membership fee to become a member of the Colorado Society of Private Investigators is \$100 for the 2017 Year.
